Hi Aryo,

There are indeed a lot of Apps that are compliant with FPP IV.2 and IV.3.

Per these policies, Apps on Facebook should not:

- post automatically on behalf of the user (this means that users should be aware that a story is going to be posted, a 'share' or 'post' button could be a good way to do that for instance).
- the story should not be pre-filled. Captions should be user-generated.

- 2. How can our member report it as spam, while they do it in purpose? They can, anytime, turn off the automate post, because the automate is turned off by default and they turn it on by himself.
